**Cancellation Policy** Your completed application is considered a commitment to the show. Any cancellations after booth fee is paid will result in a 100% forfeiture of fees.

**Booth Size** Each booth is 10' x 10'. Exhibitors must supply their own display units, tables, chairs, sun and rain protection, and power, if required. NO GENERATORS ALLOWED. Generators by permit only. Please note: Merchandise may be brought in by dolly, handtruck or wagon. No vehicles will be permitted in the exhibit area after set up and before closing of show.

**Commission** No commission will be collected. Artists are responsible for their own 6% sales tax.

**Awards** Ribbons and/or certificates will be distributed after the judging has been completed on Saturday afternoon or Sunday morning.

**Overnight Accommodations** If overnight accommodations are needed, rooms can be secured from the Best Western Concorde Inn Banquet & Conference Center, 44315 Gratiot, CT 586-493-7300.

**THE FOLLOWING MUST BE ENCLOSED WITH YOUR APPLICATION**

1. A check or money order in the amount of **\$50 deposit** (per booth fee) payable to: The Charter Township of Clinton.
2. A stamped, self-addressed **business** size envelope so we may forward your booth assignment and other information to you.

**A \$35.00 insufficient funds penalty will be charged for any returned checks.**  
*Acceptance into the show is contingent upon completion of this application and selection through the jury process. (You will be contacted regarding the location & dates).* If not accepted to the show, your entry fee will be mailed back to you with your pictures. There are no refunds once your entry fee has been processed.
